SECRETARY'S REPORT

Mr. Chairman and Gentlemen

The Secretary's Annual Report and Treasurer's Financial Statement for 1991 is submitted for your consideration and adaptation.

The beginning of the 1991 season saw the N.S.W. Rugby League change the Co-ordinator of Referees. Denis Braybrook being relocated to the Coaching and Development Academy at Narrabeen as the Referees Development Manager, to Denis thank you for your input into the Association as the referees co-ordinator over the last five years.

Don Furner was nominated by the N.S.W. Rugby League as the new co-ordinator of the Referees. As all members would be well aware, Don has had a long line of experience in Rugby League. He informed the Association that if he was not accepted by all of the active referees he would not take up the position of Co-ordinator. The Association fully supported his appointment. Don suggested the Association be involved with him in the appointments of referees with John Quayle having the final say.

The Association nominated the four newly appointed Winfield Cup Referees Coaches to work with Don on the appointments.

The coaches for the 1991 season were:- Messrs Kevin Roberts, Max Tomsett, Michael Stone and Barry Barnes the Winfield Cup and Metropolitan Cup referees coaches.

Messrs Kevin Jeffes, John Gocher and Michael Ryan the Inter-District Junior Representative Squad referees coaches.

With the retirement of Peter Murray and John Coleman as conditioners for the active referees, the Association was approached by Bob Sheens and Tony Bronson to take over the conditioning role. The Association endorsed both applicants for the 1991 season. Their training techniques compared to previous conditioners were a dramatic change for active referees. I am sure all active referees would like to see both Bob and Tony return in 1992. With new conditioners also came a change of training venue, from Henson Park to Lidcombe Oval.

Season 1991 saw a first for the N.S.W. Rugby League with Winfield Cup fixtures being played in Adelaide, Darwin, Perth and a Test match (Australia v New Zealand) played in Melbourne, all of these fixtures were controlled by members of the N.S.W. Rugby League Referees Association, congratulations to all members who received appointments in these fixtures.

Season 1992 will see both Semi-Finals of the Challenge Cup being played in New Zealand and round 4 of the Winfield Cup being played in Auckland.

The International Sevens Competition will be held at the Sydney Football Stadium on the 7th, 8th & 9th February 1992.

The Metropolitan Cup was once again an 8 team competition with the standard of football and the discipline of the players improving dramatically from the 1990 season. At this stage there looks like being 9 teams in this competition in 1992. On behalf of the Association our thanks to Tom Bellew and Paul Broughton for all their hard work in seeing this competition go ahead so quickly. Ian McCall and myself

attended most of the monthly meetings as the N.S.W.R.L. Referees Association representatives.

There were 7 monthly meetings of the Association held in 1991, all meetings were held at the N.S.W. Leagues Club starting at 7. 15pm with an average of over 73 members and delegates in attendance. The 6.00pm meetings with Don Furner and the Referees Coaches were held prior to the Associations meeting. Don invited along to one of these meetings 3 Winfield Cup coaches, Chris Anderson, Steve Martin and Graham Murray to discuss referee-coach problems.

To our Sponsors T.N.T. once again we had an excellent relationship in 1991, the current agreement ends at the end of the 1992 season, negotiations will start for future Sponsorship in mid 1992. To Lindsay Plowes, Lou Lazzari and David Redfern thank you for your continual support and involvement in the Association. All affiliated Associations are grateful to T.N.T. for their assistance with grants towards the running costs of their Associations.

Bill Petley asked to pass on his best wishes to all members of the Association, although ill health does not let him attend functions and meetings he still maintains a keen interest in the Association.

Asics Tiger Oceania Pty Ltd also continued their sponsorship support to the active members with footwear and dress shirts, thank you.

To Chris Ward, Phil Cooley and Bob Styles (sponsorship committee) thanks for a job well done.

The Annual Life Members Presentation Night, held at the S.T.C Function Centre at Canterbury, would have to be the highlight of the year with over 320

members and guests in attendance, a wonderful night and well organised by our social committee, Peter Ryan, Bob Styles and Barry Bolton.

The Association again entertained 21 of the senior Honourary and Life Members of the Association at a luncheon at the Sydney Football Stadium, our thanks to the N.S.W. Rugby League for supplying the Association with complimentary tickets for these members to the Semi Finals on that day.

The Life Members Reunion dinner was once again very well supported and I believe a good night was had by all that attended.

Members from the N.S.W, St George and Cronulla Referees' Associations entertained John and his wife at Petar's Seafood Restaurant at Brighton-Le-Sands, before his return to England.

DELEGATE'S REPORT

Although 1991 saw further advancements in the game of Rugby League particularly in its growing interest nationally I am sure that the General Manager together with the Board of the League found it to be the most difficult year since incorporation from an administrative view point. Receivership of Channel 10, the anti-smoking lobby, salary caps and the draft system culminating at the time of writing this report on a high court challenge, is to nominate but a few of the problems. It's a far cry from the days when the League was able to make passing mention of their "Honorary" solicitor.

Interstate and country venues for fixtures proved an outstanding success. This aspect will again be a feature of season '92 with competition games programmed for Darwin, Auckland, Perth and Adelaide together with Challenge Cup fixtures at Nambucca Heads, Lismore, Wagga Wagga, Bathurst, semi-finals in Auckland and Wellington (NZ) with the final in Dubbo. The season will have an early high profile start for our members with the introduction of the "International Sevens Competition" to be conducted at the Sydney Football Stadium 7th, 8th and 9th February. Melbourne will host an Australian v Great Britain test under lights at Princes Park during the year.

Praise is due to our members for their contribution to the high standard of games generally. Not just those of the Winfield Cup final series but all competition games including your strong efforts in the Metropolitan Cup. With recent emphasis again on violence in sport it was to the credit of our active men that the media was denied such sought after headlines through our competitions. On-field pressure is certainly increasing and not assisted by

regular mid season rule changes. Introduction of the rule relating to the stealing of the ball as one example posed difficulties for all concerned.

Major changes to the system of appointing occurred with the introduction of the coaches under the Leagues nominated guidance of Don Furner. These people are to be thanked for their efforts which I'm sure entailed more pressure, time, doubts and responsibility than they first contemplated. Equal thanks to those involved in the junior representative squad, next year facing an already approved 10 round competition.

Although the League has now indicated officially that no new teams will be introduced into the Winfield Cup competition prior to 1994 we as an association must be prepared for the eventuality of the games broadening and the inherent ramifications of same. General Committee meetings were few in number with total administrative thrust directed through Board decisions or via chief executive meetings at which we hold no direct representation, a point worthy of addressing for the future particularly when and if the competition is widened.

Our members face an early start once again to what no doubt will be a long and arduous season. A level of commitment as shown in the past year will assure the Association of a continuance of that well deserved quiet respect we enjoy from the genuine supporters of the game.

My thanks once again for the privilege to serve as your delegate.

Brisbane/Canberra or other distant locations. We will have to look at ways to try and streamline this strategy and thereby gain maximum results for all referees.

The three weekly, later monthly meetings with the Advisory Board /Coaches was very beneficial in that some of the information that was not included in the match reports due to their brevity was made known to the other board members and the coaching panel members.

We hope that most of the members have gained some benefit from the input by the Advisory Board and Coaching Panel members, thereby enabling them to achieve their full potential. There will be instances where some members will no doubt be unhappy with their appointments over the year, however if you look at the overall appointments realistically you will realise that no referee or touch judge was relegated by the Appointments Board during the season for any one mistake. When the Semi Finals came around every report was studied and all incidents were taken into account before gradings for the Final series were decided upon. Appointments have been made to encourage those who have given the Association a maximum effort both on the training field and during their fixtures and have basically come through the season unscathed.

Referees and touch judges should be aware they both come under the same scrutiny and must strive to perform to the highest standard in each and every appointment.. They must be dedicated to training to ensure that a high standard of fitness and personal appearance is maintained. These are essential requirements and are taken into account when considering representative and final series fixtures.

Considering what we have achieved this year and looking ahead to the 1992 season we have come to a situation where some of the members who have officiated as referees this year will be asked to consider a position purely as a touch judge. From a study of the 1991 reports some of the members have not reached the standard required to officiate as centremen in either Presidents Cup or Metro. Cup games and for this reason they will be asked in the off season to consider the option of either running touch lines or 'reverting' to the District ranks to continue their 'refereeing' careers, this will be an option open to them.

COACHES REPORT FOR 1991

Well the 1991 Rugby League season has drawn to a close and as far as the N.S.W.R.L. is concerned it has been a most successful season with over 1.5 million people passing through the turnstiles. As far as the N.S.W. Referees Association is concerned we didn't come out of it too bad. A bit of negative publicity from the 'Press' about 'Stealing of the Ball' the '5 Metres' and our application/interpretation of those rules but apart from that they didn't have too much to complain about. Our members should be commended for their efforts in working to re-establish guidelines and responsibilities that have been missing for many years.

With regard to the Referees Association Advisory Board/Coaching Panel situation we believe that the Rugby League this year have taken more of a back seat role in the appointments of referees in that they appointed Don Furner as the referees co-ordinator and left the decisions regarding appointments to our association members with the final say being made by Don and John Quayle. To Don's credit he did stipulate at the commencement of the season that no one would be relegated after one 'mistake' and this criteria was carried through the season and applied to both centremen and touch judges.

We would be the first to admit that this year has been one of a 'learning period' by the referees coaches. In the early part of the season it took us quite some time to get settled in to the task of 'grading' the referees into various categories and rankings.

We hoped we achieved our objectives as indicated at the early season seminar in that we would have the advisory board/coaches observe each 'newly graded' and lower grade referees perform as a centremen in at least 3 President's Cup (Winfield Cup) fixtures thereby allowing each referee to display his wares in other than Metro. Cup Football. Allowing for a few early season/mid season injuries to our members this objective was achieved.

As we progressed into Round 16 we had most of the centre men *allocated* into respective grades and this coincided with Don Furner's requirements. Don desired to have the central referees established so that we would have a six weeks rundown into the semi finals with central referees reasonably well established in each respective grade. Another aspect of our overall objective was to keep all our members active up until the completion of Round 22 of the Winfield Cup and this also was accomplished. Some members in the past terminating their commitments well before the final Round of the Winfield Cup competition.

One of our main 'thrusts' of the coaching panel was the mentor/mentee strategy and in some areas this concept was extremely successful in that some of the members performed to their maximum potential enhancing their performances over the season and achieved higher grade appointments. In other areas of this concept there were breakdowns and that can in some instances be attributed to the logistics e.g. coach/mentor in Sydney, Mentee/Referee, touch judge in say Gold Coast/
