



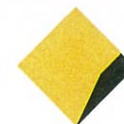

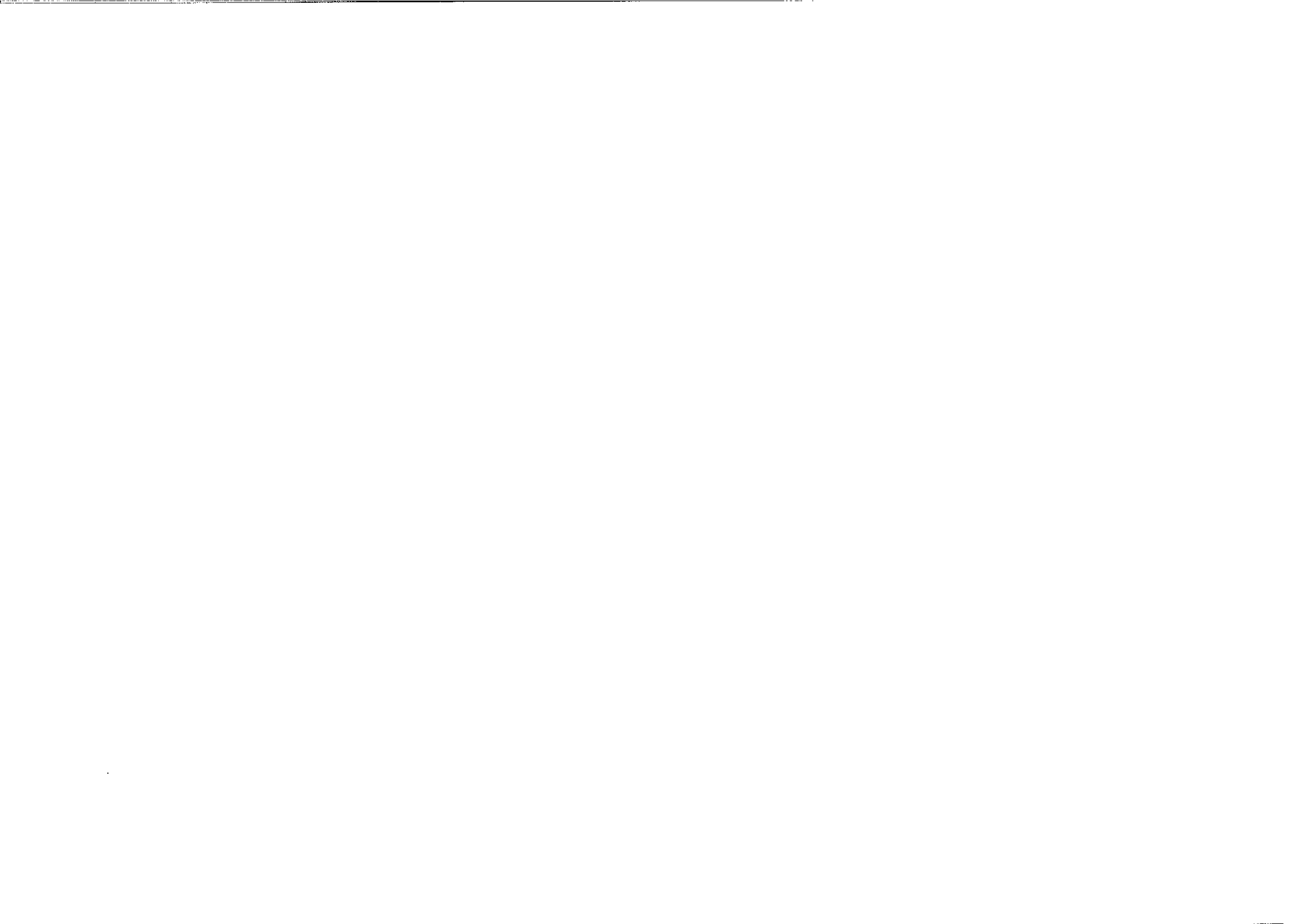

coaching strategies that we undertook this year that we pulled in the same direction. I think that we achieved this. We modified our mentor system from the previous two years. I know that a number of referees still communicate with a member with whom they accomplished a great deal of empathy. That's fine, but in keeping with our policy of "individualism", we felt that it was not a good move to foist a referee upon someone who he could not accept. So instead we chose individual members from the coaches to look after specific referees, don't be concerned if you weren't one of them, you must have been travelling all right.

A further innovation made by the Coaching Panel was the teaming of referees and touch judges for the last two months of the competition. The resultant team work heading into the semi-finals was outstanding. From the beginning of 1994, they will all go back into the melting pot.

In October, the Coaching Panel met to discuss the successes and failures of 1993 and to commence planning for 1994. Changes are likely, however I see consolidation being the name of the game next year.

A major change was the introduction of Cecil B de Pearce on the filming side. Task Specific videos were taken of referees and touch judges at the behest of the Coaching Panel. It must be said that this initiative, financed by the Association, has had spectacular results in a number of instances. In relation to the logistics of filming, every Chief Executive that was approached bent over backwards to assist in any way possible.

Speaking of the clubs, I must thank them for their support. There were a few meetings between Winfield Cup coaches and referees and generally finished on a pleasant note, if not totally in agreement.

WINFIELD CUP REFEREES COACHING CO-ORDINATOR'S REPORT

They say that one of the most difficult things that a human being must cope with is change. If that is the case, our current crop of referees are surely the most well adjusted people in the world.

Prior to the start of season 1993, the N.S.W. Rugby League appointed a full time Coaching Co-ordinator for referees. The Association then doubled its complement of touch judge coaches. Add that to the December off season testing session and everything pointed to a season of change.

The instruments of change turned out to be a Coaching Panel who exhibited great foresight and determination to succeed. We decided that success is measured in terms of eliminating errors from our game. The individual talent of referees was not in question nor was their dedication. If that was the case, then we needed to change the way that we did things and so we did, radically.

We split central referees into the First Grade Squad and Minor Grade Squad and trained them on different nights. On those nights we concentrated on drills designed to hone skills such as concentration, peripheral vision, judgement, reaction and information retention. Some nights were more strenuous than others and it must be conceded, some drills were a total failure, we dumped those, quick smart.

To maintain enthusiasm throughout a long season on cold training grounds is difficult. So it was that in an effort to make the session more "interesting", some of the more mundane drills were put on the back burner. Some weeks later when it was observed that our performances had slipped decidedly on the field in certain areas, the referees themselves volunteered that the reason was a paucity of drills designed to practice that particular skill. We had all learnt a valuable lesson.

Touch judges also took the quantum leap into practising skills, Ian McCall and Max Tomsett spent endless hours kicking goals, throwing footballs at corner posts, stepping on touch lines etc, etc, in an effort to emulate the match situation on training nights. They even created a short video which Kevin Roberts promptly destroyed with an ill timed expletive.

Mirror image training sessions were set up in Queensland and in Canberra so that, as far as possible, alleged communication difficulties of previous seasons could be eliminated. It must be remembered, however that communication is a two way process, those who will not listen, cannot possibly hear anything.

As big as the changes were off the field, the on field changes were bigger and received criticism in some quarters. To those who criticised the increased involvement of touch judges in the decision making process, the Coaching Panel makes no apology. As mentioned earlier, our commitment was to eliminate errors from our game. We have five officials on the field and we believe that we should make the best possible use of them. Thanks to the confidence of our on field officials, we think that this move has been an unqualified success. Even the media joined in to heap plaudits on the referees and of course, we continued to trial the electronic communication system.

The winds of change also swept through the Advisory Board. At this time, I think it is appropriate to extend my personal thanks to a group of men who, at the beginning of the year, demanded feedback. By the end of the year, they realised that feedback was not always a totally pleasant experience. Nonetheless, change we all did, albeit somewhat reluctantly at times. It was imperative to the success of the various
