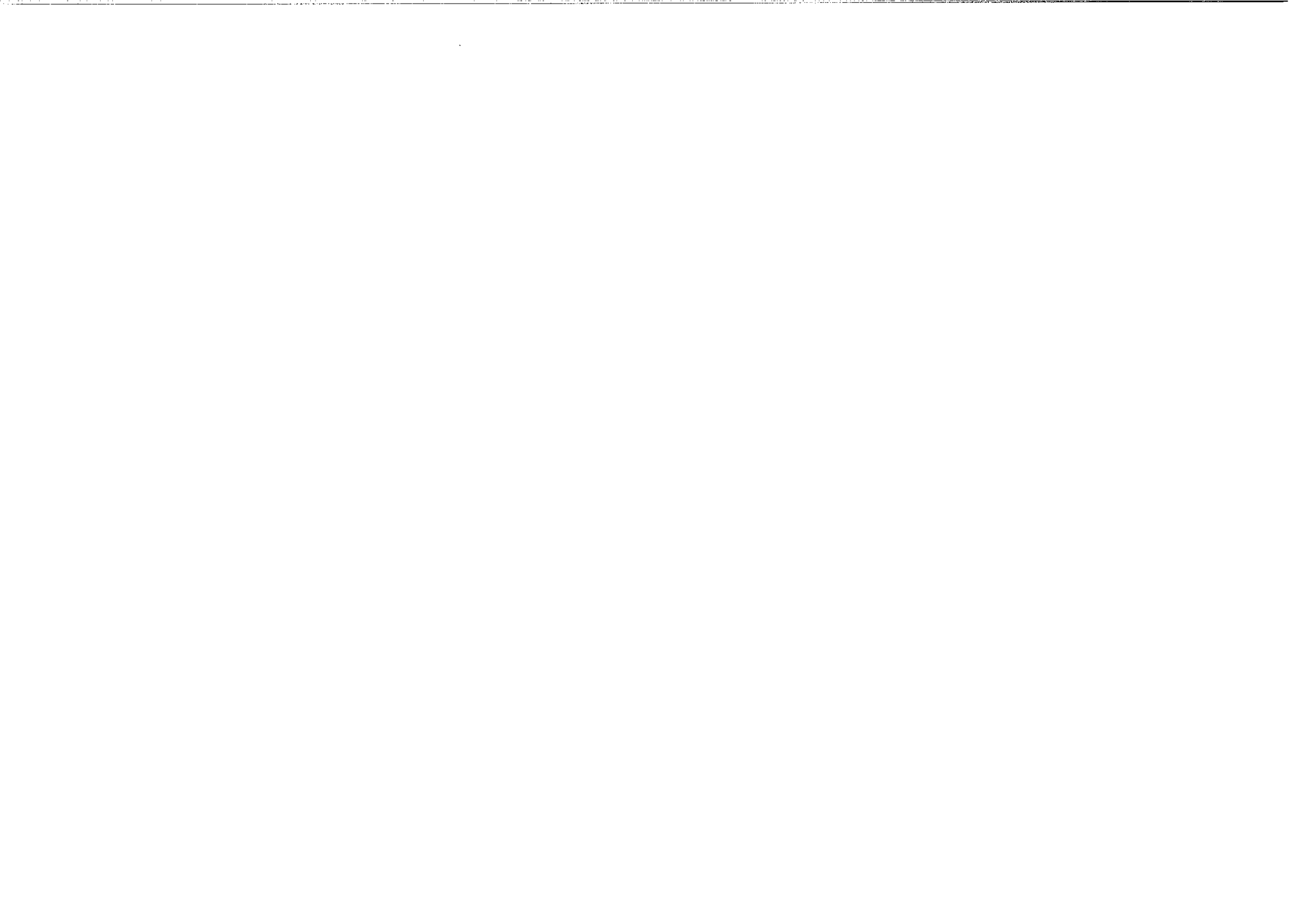

TREASURER'S REPORT

Well, another season is over and now is the opportunity for members to assess the financial performance of the Association for 1992.

The season 1992 witnessed a continuation of the simple accounting procedures utilised in previous years. In tough financial times accurate monitoring of financial performance is essential and the simple methods always prove to be the most effective. Our performance continues on a steady path and our position is sound.

There are a few areas of concern, especially relevant to the active membership. These difficulties relate to structural problems associated with fee recovery and prompt payment of fees generally. There is a need to develop clearer, more positive policies in relation to these matters, opening up lines of communication to the satisfaction of all parties. This needs to be negotiated early in 1993.

Statements of Account have been prepared using the same methodology as in previous years. They serve as a useful monitoring tool and I would encourage all members to read them carefully.

At the time of writing this report the new sponsorship agreement with TNT was still in the final negotiating stage. I am sure that the agreement will be signed very soon thus extending a highly successful and rewarding sponsorship. No other organisation within league ranks can boast such a long standing and successful association.

Fellow Members,

This year being the final year of our current agreement with TNT was always going to be difficult, due to the inevitable budget "over-runs" of the previous years.

However due to some effective "belt tightening" efforts by all concerned, particularly our hard working Gear Steward, Phil Cooley we were able to survive without any disadvantage to our active members.

Our Association through the sponsorship was able to continue its part in propagating the game on a national and local level. Financial and gear assistance in addition to coaching and administrative support was provided to the South Australian, Victoria, Northern Territory, Western Australia, Norfolk Island and Country Rugby League Referees Associations. Gear was also allocated to the University Cup Referees Association to assist them in conducting the student Rugby League World Cup which was held in Sydney this year.

DELEGATE'S REPORT

Apart from that now rare result in the State of Origin series and the make-up of the final five of the Winfield Cup competition compared to what was envisaged in February, the season held few surprises. On the surface a good year with high attendances and a pleasing standard of football in the semi-final and final series, however, like the rendition of the National Anthem on Grand Final day, not as comfortable as the League would have liked it to be. Like all in the business community the League is suffering the side effects of the now supposed "well over" recession. Apart from ceiling caps, reduction in TV revenue and the number of clubs facing serious leagues club related revenue problems, they are seeing the down-turn in the sponsorship dollar which was that much more easily obtainable during the 80's. A serious waning in junior league teenage competitions in a number of districts must also be of concern.

I feel referee standards were maintained and apart from a few unfortunate low spots towards the end of the competition rounds, those appointed to their great credit, lifted performances to the levels expected for the final series. This controversy-free series must have come as a disappointment to the media. It would have been quite a literary shock to have to concentrate on simply reporting the game.

The League has employed Michael Stone in the capacity of Winfield Cup referee's coach for next season. No-doubt like his predecessors he will face a number of interesting tasks. It appears that official training will be

extended to two nights per week with little doubt it can be argued promoting some improvement in the level of performances. However, a point that must be considered is the negative effect this will have on the district associations which are heavily reliant on the input by the active grade referees. As opposed to 20 years ago when older members continued their involvement beyond their active years the 90's sadly see a limiting of such contributions and a considerable number of active grade referees currently fill administrative, appointing and coaching roles. I am convinced the additional training time required will have serious ramifications on this involvement. It must be remembered that district associations are the primary suppliers of grade referees and the League does continue to expect a professional approach from what in principle are amateur bodies.

Michael's greatest task will be in addressing the gap which exists between League officials' philosophy on how games should be refereed in comparison with that on how referees see the rules best applied.

You all should be reminded of the changes to rules in 1993. The approach to scrums will need great consideration to say the least, particularly if the insistence remains that penalties can't be used to solve the inevitable problems.

Again many thanks for the honour of representing the Association and best wishes for what should be an interesting season.
